IN CONSIDERATION of this minor being permitted to participate in any paintball activities including, but not limited to, playing, using the premises of, renting and operating equipment leased, sanctioned and or operated by the above named vendor, I acknowledge and claim that ;

1. I will instruct and assist the minor participant, and prior to participating, we will inspect the facilities and equipment to be used, and if I, or the minor participant, believes anything is unsafe, we will immediately notify the staff. If the safety issue cannot be remedied to my satisfaction, I will ask for an immediate refund.

2. I fully understand that each participant will be engaged in activities that involve risk of serious injury, including permanent disability, blindness and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.

3 I assume all the risks and accept responsibility for the damages following such injury, permanent disability, blindness, or death.
